## Exhibitor Information

Please pick up after your dog and dispose of waste in appropriate containers outside the building. When not competing, dogs must be crated or on leash and under control at all times.

**Ring Location:** The ring will be located behind the school property and will be surrounded by orange snow fencing on all sides .

**Safety:** At all times, the safety of the dogs and handlers is to be of paramount importance.

**Crating:** Exhibitors may crate in their car or under temp shade. There is very little shade so we encourage you to bring shade and plenty of water for yourself and your dog.

**Leashes and Collars:** Prong, choke, electronic, and Flexi-leads are forbidden on the show grounds. Martingale collars, slip leads, harnesses and buckle collars are allowed.

**Bitches in season:** Are allowed to compete but must wear panties.

**Refunds:** No event fee will be refunded if the event cannot open or be completed by reason of riots, civil disturbances, fire, and act of God, public emergency, act of a public enemy, or any other cause beyond the control of the event committee. Entry fees will not be refunded in the event that a dog is absent, disqualified, sick, excused, or barred from competition by action of the Event Committee.

***Refunds are ONLY allowed if requested before the closing date.***
